

# C.M.A. COURSE ENROLLMENT REQUIREMENTS

### The following conditions must be met prior to enrollment:

- Must be 18 y.o. and hold an active KS C.N.A. Certificate.
- Be able to provide proof of a "negative"
   TB test that is not older than I year prior to the start of class.
- 3. Nelson-Denny reading assessment. With a score of 8 or higher.
- \* The Nelson-Denny is administered in the Student Testing Center on Mondays or Thursdays. Assessment will take approximately 45 minutes and is free of charge.
- Student must present a photo I.D. Without an I.D. student will not be allowed to test.

- You will be given a score sheet upon completion of the assessment which you will need to bring with you to enroll.
- 3. Once you have completed the Nelson-Denny assessment you will take the score sheet, Social Security card & Photo ID to the nursing Dept. in the Penka Building to complete enrollment for the C.M.A. Program.

#### C.M.A. COURSE DESCRIPTION

The course consists of a minimum of 75 clock hours and includes both class work and clinical experience to prepare the student for basic techniques & safety in medication administration.

The course includes the study of commonly used drugs, their classifications, & side effects.

A CMA works under the supervision of an RN or LPN to dispense medications to residents, perform treatments, and prepare documentation.

The course will qualify the student to take the Kansas State C.M.A. Certification Examination. After passing the State Exam the C.M.A. is qualified for employment in nursing homes as well as other health care faculties.

Enrollment for each C.M.A. class will be on a first-come, first-served basis.
