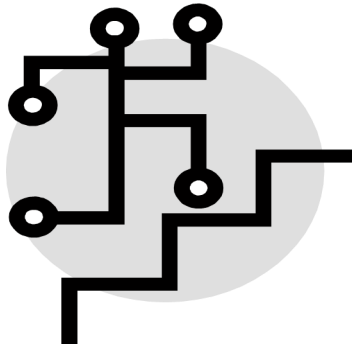

ITEMS REQUIRED FOR CLASS

C.N.A. COURSE ENROLLMENT REQUIREMENTS

The following conditions must be met prior to enrollment:

1. Be able to provide proof of a “**negative**” TB test that is not older than 1 year prior to the start of class.
2. Nelson-Denny reading assessment. With a score of 6 or higher.
 - * The Nelson-Denny is administered in the Student Testing Center on Mondays or Thursdays. Assessment will take approximately 45 minutes and is free of charge.
 - * Student must present a photo I.D. Without an I.D. student will not be allowed to test.
 - * For testing times and information call: 620-276-9560
 - * You will be given a score sheet upon completion of the assessment which you will need to bring with you to enroll.
3. Once you have completed the Nelson-Denny assessment you will take the score sheet, Social Security card & Photo ID to the nursing Dept. in the Penka Building to complete enrollment for the C.N.A. Program.

C.N.A. COURSE DESCRIPTION

The course consists of a minimum of 90 clock hours and includes both class work and clinical experience to prepare the student to provide patient care in an adult care home.

The course includes basic knowledge and skills necessary to help meet the psychosocial, physical and environmental needs of the elderly patient.

The C.N.A. is prepared to give patient care under the supervision of a registered nurse, licensed practical nurse or physician.

The course will qualify the student to take the Kansas State C.N.A. Certification Examination. After passing the State Exam with a score of 75 or higher, the C.N.A. is qualified for employment in nursing homes as well as other health care facilities.

This course also meets the C.N.A. prerequisite for GCCC nursing program.

Enrollment for each C.N.A. class will be on a first-come, first-served basis.
